Litigation between Christians in Civil Courts [1 Corinthians 6:1-8]

It is quite possible that I Corinthians 6:1-8 has been misapplied from the time Paul first penned the epistle until the present day. When a misapplication occurs, it may be the result of a twisting of scripture: "as also in all his epistles, speaking in them of these things, in which are some things hard to understand, which untaught and unstable people twist to their own destruction, as they do also the rest of the Scriptures" [II Peter 3:16]. While there may be little that can be accomplished relative to those who twist the scriptures on purpose in order to justify their actions, this article may be helpful to those who simply misunderstand what Paul is dealing with.

"Dare any of you, having a matter against another, go to law before the unrighteous, and not before the saints?" [I Cor. 6:1]. The word "dare" in verse one implies that when Christians appear before a worldly court [instead of the saints] in order to settle differences between themselves, they are acting in a way that is contrary to the will of Christ. Although worldly courts are not altogether "unrighteous", they are considered unrighteous when compared with God the supreme judge. Christians should not have to contend with one another, but if a brother sins against another, Jesus gives the rules for resolving these matters in Matthew 18:15-20. By neglecting the law of Christ and seeking resolution of differences in a worldly court, Christians transgress God's law and bring unnecessary reproach upon the Lord's church.

"Do you not know that the saints will judge the world? And if the world will be judged by you, are you unworthy to judge the smallest matters? Do you not know that we shall judge angels? How much more, things that pertain to this life?" [I Cor. 6:2-3]. Through the

preaching of God's word the saints will judge the world [and angels] in the sense that the world will be judged by whether or not it conforms to the eternal principles embedded in the Word. Not that differences between Christians are unimportant, but when compared to matters such as eternal life in Heaven, matters "that pertain to this life" are considered to be the "smallest" of the two. Furthermore, matters "that pertain to this life" cover a broad range of subjects and are not limited to money matters as some claim.

"If then you have judgments concerning things pertaining to this life, do you appoint those who are least esteemed by the church to judge? I say this to your shame. Is it so, that there is not a wise man among you, not even one, who will be able to judge between his brethren? But brother goes to law against brother and that before unbelievers!" [I Cor. 6:4-6]. Verses 4-6 are a sharp criticism of Christians who take "things pertaining to this life" before worldly courts comprised of unbelievers [who are esteemed less than brethren] instead of the church. The church is capable of resolving their differences by utilizing the truths of God's word.

"Now therefore, it is already an utter failure for you that you go to law against one another. Why do you not rather accept wrong? Why do you not rather let yourselves be cheated? No, you yourselves do wrong and cheat, and you do these things to your brethren!" [I Corinthians 6:7-8]. Verses 7-8 indicate that regardless of the judgment, Christians should accept wrong instead of being involved in an utter failure by appearing before worldly courts in order to settle differences "concerning things pertaining to this life."

However, in some situations it would not be wrong for a Christian to appear before a worldly court with another Christian. Example # 1: Jesus gives the innocent partner in a marriage the right to a legal divorce from an adulterous spouse [Matthew 19:9]. Example # 2: If one Christian does sue another, the defendant has the right to a legal defense. Paul and Jesus defended themselves against false charges [Acts 20:1; 25:11-12 and John 18:33-28; 19:7-11]. Example # 3: If one Christian witnessed another Christian committing a criminal act, reporting the criminal act and testifying in court would be a moral and legal responsibility [Romans 13:1]. No Christian has the right to break the law and then deny another Christian the right to appear with them in court based upon I Corinthians 6:1-8.

Differences between Christians "concerning things pertaining to this life" can be resolved before the saints if all parties are totally committed to Christ and in submission to His will. Litigation between Christians in civil courts brings reproach upon the church of our Lord and should be avoided if at all possible.
